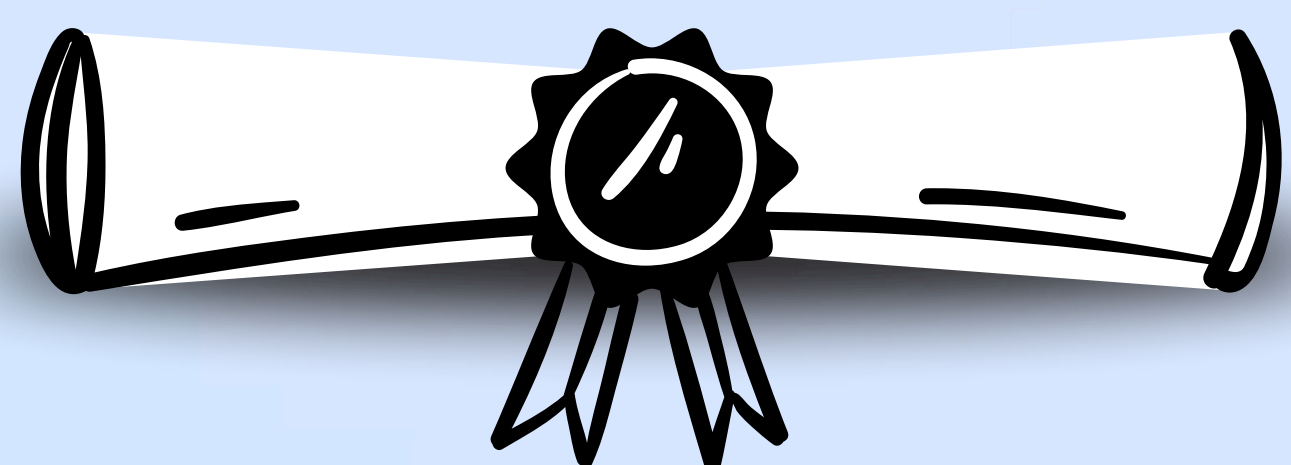
Message from the Chancellor's Desk
